ORDER

Sri. Prasanth. N.S, Asst.Engineer has filed OA(EKM) 1205/2018 before the Hon'ble Kerala Administrative Tribunal aggrieved by non inclusion of his name in the select list for promotion to the post of Asst.Exe.Engineer by the DPC(H) 2018 which held on 14.12.2017, due to the pendency of disciplinary action for major penalty in connection with the irregularities in the Parakavala- Pathrukavala road tarring work of Mullankolly Grama Panchayath.

2. The Hon'ble Kerala Administrative Tribunal, vide order read as 1st paper above, have disposed of OA(EKM) 1205/2018 directing the 2nd respondent, ie the Convenor, DPC(H) to take a decision on Annexure A8 representation, read as 2nd paper above, before the date on which the meeting of the DPC is to be held.

3. The request of the applicant in the Annexure A8 representation to reconsider the above decision of the DPC and to include him in the modified select list 2018 for promotion to the post of Asst. Executive Engineer.

4. The review DPC(H) which convened on 10.07.2018 in pursuant to the above orders of the Hon' KAT has observed that the applicant is eligible for promotion to the cadre of Asst.Exe. Engineer as disciplinary action for major penalty prevailed against the applicant was finalised by awarding a minor penalty of withholding one annual increment without cumulative effect for a period of one year from his salary, vide GO(Rt)No. 1724/2018/LSGD dated 25.06.2018. Therefore the review DPC(H) has decided to include him as Sl. No.12(a) just below Smt. Neeba. Y, whose Sl. No. is 12 and Rank No. is 224 (Direct Quota), in the modified select list 2018 for promotion to the post of Asst.Exe. Engineer. Subsequently, the modified select list 2018 has been approved and published vide GO read as 3rd paper above.

5. In the above circumstances, as the applicant has been included in the modified select list 2018 for promotion to the post of Asst.Exe.Engineer after considering his review petition, the order of the Hon'ble KAT in OA(EKM) 1205/2018 read as 1st paper above is complied with accordingly.
