**ORDER**

Government of India, Ministry of Rural Development had issued Guidelines for engaging third party concurrent monitoring & phase wise evaluation of PMKSY- WDC (earstwhile IWMP) Projects. As per Operational Guidelines (Point No.18) of PMKSY issued by the Ministry of Rural Development, the State Governments are free to choose any reputed agencies for conducting the monitoring and evaluation of PMKSY- WDC (earstwhile IWMP) Project works in their States. Requisite fees/cost towards monitoring & evaluation will be met by the State Government from the 5% allocation retained by them for administrative expenses. The Commissioner for Rural Development, as per letter read above has requested to accord sanction for entrusting the end line evaluation of 83 PMKSY-WDC (earstwhile IWMP) Projects in Kerala to CWRDM, Kozhikode at a total cost of Rs.29.15 lakhs over a period of 4 years and also informed that expenditure in this regard can be met from the programme fund.

2. Government have examined the matter in detail and are pleased to accord sanction for entrusting the end line evaluation of 83 PMKSY-WDC(earstwhile IWMP) Projects in Kerala to CWRDM, Kozhikode at a total cost of Rs.29.15 lakhs over a period of 4 years, subject to the condition that, the expenditure towards the cost of evaluation shall be met from the programme fund itself. No additional fund will be sanctioned for the purpose.
