**ORDER**

As per the G.Os. read as 1st and 2nd paper above, an amount of Rs.180.826 Crore and Rs.3.432 Crore (Total Rs.184.258/-) has been resumed from the Special TSB Account of AMRUT. Out of these an amount of Rs.38.87 Crore has been released to AMRUT vide G.O. read as 3rd paper above. Hence the balance fund to be released to AMRUT for re-allocating the resumed fund comes to Rs.145.388 Crore.

2.As per letter read as 4th paper above Mission Director,AMRUT has requested to accord sanction an amount of Rs 171.219 Cr to AMRUT and to transfer credit the amount to PSTSB account No 363 maintained for Centrally Sponsored Scheme by the Mission Director,AMRUT in the Sub Treasury, Vellayambalam, as fund is urgently required for the implementation of various projects under AMRUT.

Government have examined the matter and pleased to accord sanction to release funds as detailed below, for re-allocating the fund resumed during the financial year 2017-18,vwith permission to transfer credit the amount to PSTSB account No 363 maintained for Centrally Sponsored Scheme by the Mission Director,AMRUT in the Sub Treasury Office,Vellayambalam.
