ORDER

As per the sanction order read 4th above Government of India have sanctioned a total amount of Rs.19,34,12,000/- (Rupees Nineteen Crores Thirty Four Lakhs Twelve Thousand Only) towards part payment of 2nd installment of Central Share to Kudumbashree, State Poverty Eradication Mission, Kerala in respect of Annual Action Plan (AAP) under Start up Village Entrepreneurship Programme (SVEP) for promotion of enterprise based livelihood in the 12 blocks identified for the purpose, for conducting baseline and market potential study. Government of India have directly credited the amount to Kudumbashree through RTGS. The Executive Director, Kudumbashree, as per letter read as 6th paper above, has requested to accord sanction for releasing the State Share amounting to Rs.12,89,41,333/- corresponding to the Central Share of Rs.19,34,12,000/-.
