**ORDER**

In the 5<sup>th</sup> Governing body meeting of VMHS under the Chairmanship of the Hon'ble Chief Minister of Kerala, read as first paper above, it was decided in principle, to entrust Kochi Metro Rail Ltd. with the design and execution of the second phase of Vyttila Mobility Hub project by utilizing AFD fund at the proposed interest rate of 6 monthly EURIBOR rate +155 Basic point per annum and KMRL had selected M/s IPE Global Ltd, New Delhi, as the consultant through tender process for the preparation of Detailed Project Report of the said project for an amount of Rs. 1,20,65,500/- ( Rupees One Crore Twenty Lakh Sixty Five Thousand and Five Hundred only).

2) The Managing Director of Vyttila Mobility Hub Society, as per letter read as second paper above has requested Government to accord sanction for transferring Rs. 1,20,65,500/- to KMRL from the fund available with VMHS, to KMRL.


