**ORDER**

A total amount of Rs 394 Crore has been credited to the Treasury Savings Bank Account of Cochin Smart Mission Limited (CSML) during the Financial Years 2016-17 and 2017-18, out of which an amount of Rs.393.79Crore was resumed by Government. Later, an amount of Rs 61.77 Crore has been released to CSML as per the G.Os read above towards re-allocation of resumed fund. As such, the balance amount to be released to CSML is Rs 332.02 Crore, as detailed below:-
