ORDER

1.As per the G.O read as 1st paper above, Administrative Sanction was accorded to the AMRUT project 'Foot Over Bridge at Nehru Trophy Starting Point' in Alappuzha Municipality (2016-17) for an amount of Rs.1.86 Crore. During the detailed structural scrutiny it was observed that, the worst condition of loading was not considered in the design and hence revised estimate was prepared for Rs.2.41 Crore. The 20th State level High Powered Steering Committee (SHPSC) of AMRUT held on 11/12/18 approved the revised estimate subject to the condition that, the Team Leader of SMMU shall certify the reason for enhancement. The Mission Director as per the Note read as 4th paper above has submitted the Certificate of Team Leader explaining the reason for enhancement.

2.As per the G.O. read as 2nd paper above, Administrative Sanction was accorded to the AMRUT project 'New Payyambalam Park' in Kannur Corporation (2017-18) for an amount of Rs.0.45 Crore. After structural vetting it was suggested to re-design the foundation & Cantilever beams for strengthening which increased the cost to Rs.0.705 Crore. The 20th SHPSC held on 11/12/18 has approved the revised estimate.

3.The 20th SHPSC of AMRUT held on 11/12/18 has also decided to approve the following project in Alappuzha Municipality (2016-17) at an estimated cost of Rs.7.00 Crore:-

Improvement of 3 Pozhis

- i. Improvement of Vada Pozhi.
- ii.Improvement of Ayyappan Pozhi with Walk Ways and Pedestrian Network.
- iv.Improvement of Thumpoli Pozhi.
