ORDER

As per letter read as 1st paper above Government of India have released an amount of ₹2,25,00,000(Rupees Two crore and Twenty Five Lakh only) as the 2nd installment of Administrative Funds to the State Government of Kerala under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19. As the funding pattern between Central and State Government under PMGSY is 60:40 the State Govt. has to release an amount of Rs ₹1,50,000,00/- (Rs. One crore fifty Lakhs only) as corresponding State Share along with the Central Share received. As per the letter read as 2nd paper above, the Member Secretary, KSRRDA has submitted proposal for the release of the aforesaid central share and the corresponding state share from the H/A 4515-00-800-98(01) and 4515-00-800-98(02) respectively.

2. Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹2,25,00,000(Rupees Two crore and Twenty Five Lakh only) to KSRRDA, as 2nd instalment of Central Share of Administrative Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19 along with the matching State Share of ₹1,50,000,00 (Rupees One crore fifty Lakhs only) by debiting the expenditure under the H/A 4515-00-800-98(01) and 4515-00-800-98(02) respectively and to transfer credit the amount to the PSTSB Account No. 799012700000447 of Commissioner for Rural Development and Member Secretary, KSRRDA at District Treasury, Thiruvananthapuram.
