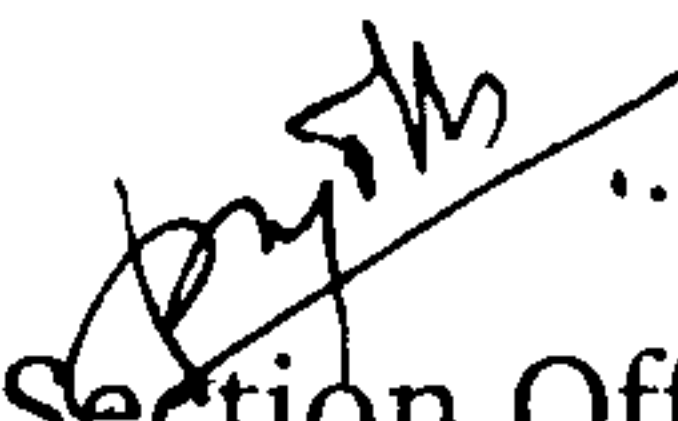
VI. The incumbents shall join forthwith in their respective posts and furnish the RTCs to Government without fail.
