ORDER

As per the Government Order read as 2nd paper above sanction was accorded for the release of an amount of ₹4,64,78,000/- to Kudumbashree towards the second installment of state share under National Rural Livelihood Mission (NRLM) (General Component) during the financial year 2017-18. An amount of ₹3,42,99,333/- was also sanctioned towards third installment of state share under National Rural Livelihood Mission (NRLM) (General component) during the year 2017-18 as per the Government order read as 3rd paper above. Due to unavailability of sufficient fund under the Head of Account 2501-06-197-48 (04) NRLM- General (40% State Share), the funds were not released during the financial year 2017-18. Now the Executive Director, Kudumbashree as per his letter read as 4th paper above has requested to release the aforesaid amount from the current year's Budget allocation.

2. After having examined the matter in detail, Government are pleased to accord sanction to release an amount of Rs.8,07,77,333 towards the 2nd and 3rd installment of State Share (General) for the implementation of NRLM/Ajeevika for the year 2017-2018 from the current year's (2018-19) Budget provision as detailed below.
