**ORDER**

Government of India had approved an Annual Action Plan of Rs.51.78 Crore to the State for Rashtriya Gram Swaraj Abhiyan (RGSA) for the Year 2018-19. As per the G.O read as 2nd paper above administrative sanction has been accorded for an amount of Rs.51.78 crore for the implementation of the scheme in the State during the Year 2018-19. The activities approved for the Years 2017-18 and 2018-19 are progressing.

2. As per the letter read as 1st above, Ministry of Panchayati Raj, GoI had sanctioned an amount of Rs.3.18 Crore to the State as Central Share for carrying out the interventions under Rashtriya Gram Swaraj Abhiyan (RGSA) on the basis of Approved Annual Action Plan of the State for the Year 2018-19. The Director of Panchayats as per letter read as 3rd paper above has requested to release the Central Share received along with corresponding State Share in the ratio 60:40 for the implementation of RGSA for the year 2018-19.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.6 Crore (Rs.3.18 Crore as Central Share and Rs.2.82 Crore as State Share) under the h/a 2515-00-101-56-plan for implementing Rashtriya Gram Swaraj Abhiyan (RGSA), with permission to transfer credit the amount to the Bank Account No. SB.33330917889 maintained by the Director of Panchayats in SBI Pattom Branch (IFSC SBIN0003355), subject to the conditions specified in the letter of GoI read as 1st paper above.
