ORDER

Government of India vide letter read as 1st paper above have released an amount of Rs.32,89,74,000/-(Rupees Thirty Two Crore Eighty Nine Lakh Seventy Four Thousand only) to the State Government of Kerala as partial payment of 4th installment of 2nd tranche of Central Assistance towards material and administrative components for implementation of MGNREGA for the financial year 2018-19. The Mission Director(MGNREGS) vide letter read as 2nd paper above submitted a proposal for release of central share received along with corresponding state share.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs.32,89,74,000/- being the 4th installment of 2nd tranche of Central Assistance received towards material and administrative components of MGNREGA along with an amount of Rs.8,90,46,000/-(Eight Crore Ninety Lakh Forty Six Thousand only) being the corresponding state share towards material component for the financial year 2018-19 as detailed below:
