ORDER

As per the Guidelines issued by Government of India for the implementation of MGNREGA, there will be a State NREGA Cell headed by an NREGA Commissioner deputed by State Government and the remuneration of the Commissioner so appointed will not be borne from the Central Assistance. As per the Government Order read as 1st paper above, an ex-cadre post of Mission Director, Mahatma Gandhi National Rural Employment Guarantee Scheme was created in the Senior Time Scale of I.A.S. and subsequently an IAS Officer was posted as Mission Director in MGNREGS vide Government Order read as 2nd paper above. In view of the Audit Objection raised in the Audit Report of Government of India read as 3rd paper above regarding disbursement of Pay & Allowances of the regular staff appointed in State Mission from the Administrative Head of MGNREGS, the Mission Director as per the letter read as 4th paper above has requested to take further action to include the post of Mission Director in the Pay Roll of State Government and to disburse the salary through Treasury.

2. Government have examined the matter in detail. The pay and allowances of an ex-cadre post has to be met from the concerned Head of Account of the office in which the officer is appointed. Since the Administrative Cost component of MGNREGS does not include the State Share portion, sanction is accorded to meet the Pay and Allowances of the Mission Director(MGNREGS) from the Head of Account 2505-02-101-99(02)-MGNREGP(State Share). The Mission Director, MGNREGS shall submit necessary proposal including actual salary requirement, for authorization of the amount for the purpose.
