**ORDER**

Government of India as per the letter read as 1<sup>st</sup> paper above have released an amount of Rs.27,88,67,000/- to the State Government of Kerala on account of partial payment of 1<sup>st</sup> part of 1<sup>st</sup> tranche of Central Assistance towards material and administrative components for implementation of MGNREGA for the financial year 2019-20. The bifurcation of material and administrative components were intimated vide corrigendum read as 2<sup>nd</sup> paper above. The Mission Director(MGNREGS) as per the letter read as 3<sup>rd</sup> paper above submitted proposal for releasing the central share received along with corresponding state share.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of **Rs.27,88,67,000/-(Rupees Twenty Seven Crore Eighty Eight Lakh Sixty Seven Thousand only)** being the partial payment of 1<sup>st</sup> part of 1<sup>st</sup> tranche of Central Assistance received towards material and administrative components for implementation of MGNREGA for the financial year 2019-20 and an amount of **Rs.8,73,78,327/-(Eight Crore Seventy Three Lakh Seventy Eight**

Thousand Three Hundred and Twenty Seven only) being the corresponding state share towards material component for the financial year 2019-20 as detailed below.
