ORDER

As per the Sanction Orders read as 3rd paper above, Government of India have sanctioned the grant-in-aid amount of Rs.12,54,48,000/- (General), Rs.4,27,60,000/- (SCP), Rs.8,26,88,000/- (TSP) respectively towards the 2nd installment of Central Share for implementation of NRLM/Ajeevika for the year 2018-19. As per the Government Order read as 2nd paper above, sanction has been accorded to release the aforesaid General & SCP components of Central and State Shares of NRLM/Ajeevika to Kudumbasree. Due to lack of sufficient fund under the Head of Account 2501-06-796-99 during 2018-19, the Central and State shares of TSP component was not released. As per the letter read as 5th paper above, the Executive Director, Kudumbasree has reported that State Share of General Component amounting to ₹8,36,32,000/- sanctioned as per G.O. read as 2nd paper above was not credited to the Account of Kudumbashree during the Financial year 2018-19.

After having examined the matter in detail, Government are please to accord sanction to release a total amount of ₹22,14,45,333.33/- towards the Central and State Share of TSP component and State Share of General component under NRLM/Ajeevika for the year 2018-2019 from the current year's Budget provision as
