ORDER

As per the Sanction Orders read as 1st paper above, Ministry of Housing & Urban Affairs, GoI have released a total amount of Rs.18,59,94,000/- as first and final installment of Central Share to Govt of Kerala under DAY-NULM during 2018-19 as detailed below:-

General - Rs.13,61,47,610/-  
SCP -Rs. 4,18,48,650/-  
TSP - Rs. 79,97,740/-  
Total - Rs.18,59,94,000/-

2.As per the G.O read as 2nd paper above sanction has been accorded to release an amount of Rs.30,99,90,000/- to Kudumbashree, the Nodal Agency of DAY-NULM, as first and final installment of Central Share received from GoI along with matching State Share under DAY-NULM during 2018-19. But only an amount of Rs.8,16,88,566/- (Central share - General Component of Municipality) has been credited to the NULM Account of Kudumbashree from the the H/A 2217-05-192-74 (Municipality) during the financial year 2018-19. Therefore as per the letter read as 3rd paper above the Executive Director, Kudumbashree has requested to release the balance amount from the current year's Budget Provision

3.Government have examined the matter in detail and pleased to accord sanction to release an amount of Rs.5,44,59,044/- (State Share) from H/A 2217-05-192-74-General Municipalities and Rs.9,07,65,073/- (Central Share & State Share) from H/A 2217-05-191-77-General Corporation, to Kudumbashree under DAY-NULM for the Year 2018-19, sanctioned vide G.O. read as 2<sup>nd</sup> paper above.

proposal identifying savings under General Component for releasing the Central and State Share of SCP and TSP Components.
