ORDER

Ministry of Rural Development, Government of India informed vide reference read first above that has scheduled a National level workshop on experience sharing by elected representatives from Syama Prasad Mukherji Rurban Mission clusters on 24.06.2019 at SCOPE Complex, New Delhi. It has been directed to nominate officials and 1-2 elected representatives from each cluster up to five progressive clusters in the state to attend the workshop.

were forced to perform the journey to New Delhi and back for the purpose by air considering the significance of the workshop and communication received from Govt. of India, in short notice. Hence the Commissioner for Rural Development has requested to issue sanction for the elected representatives nominated for attending the workshop to perform their journey by flight as a special case.
