ORDER

As per the letter read as 2nd and 3rd papers above, Government of India have sanctioned the grant-in aid amount of Rs.9,53,52,000/- (General), Rs.5,47,27,000/- (SCP), and Rs.4,06,29,000/- (TSP) respectively to the State towards the IIIrd instalment of Central Share for implementation of National Rural Livelihoods Mission (NRLM) / Ajeevika for the year 2018-2019 by Kudumbashree, Kerala SRLM. As per the letter read as 4th above, the Executive Director, Kudumbashree has requested to release the aforesaid Central Share received from Govt. of India along with the corresponding State Share for the above purpose.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.9,53,52,000/- (Nine Crore Fifty Three Lakhs and Fifty Two Thousand Only) as the Central share (General Component), Rs.5,47,27,000/- (Five Crore Forty Seven Lakhs and Twenty Seven Thousand Only) as Central Share (SCP component) and Rs.4,06,29,000/- (Four Crore Six Lakhs and Twenty Nine Thousand only) as Central Share (TSP component) towards the IIIrd instalment of Central Share for implementation of National Rural Livelihoods Mission (NRLM) / Ajeevika for the year 2018-2019 from current years budget provision by Kudumbashree, Kerala SRLM along with the corresponding state share as detailed below:-
