**ORDER**

Government of India vide letter read as 1<sup>st</sup> paper above have released an amount of Rs.240,22,33,000/- (Rupees Two Hundred Forty Crore Twenty Two Lakh and Thirty Three Thousand Only) to the State Government of Kerala on account of payment of 2<sup>nd</sup> installment of 1<sup>st</sup> tranche of Central Assistance towards material and administrative components for implementation of MGNREGA for the financial year 2019-20. There is no component wise bifurcation for this release. The Mission Director(MGNREGS) vide letter read as 2<sup>nd</sup> paper above submitted a proposal for release of central share received along with corresponding state share.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs.240,22,33,000/- (Rupees Two Hundred Forty Crore Twenty Two Lakh and Thirty Three Thousand Only) being the 2<sup>nd</sup> installment of 1<sup>st</sup> tranche of Central Assistance received towards material and administrative components for implementation of MGNREGA for the financial year 2019-20 and an amount of Rs.56,07,44,000/-(Fifty six Crore Seven Lakh Forty Four Thousand only)- being the corresponding state share towards material component for the financial year 2019-20 as detailed below.


