ORDER

Perinthalmanna Municipality has proposed to construct 34 residential apartment blocks each having 12 dwelling units in Perinthalmanna in 6.93 acres of land owned by the Municipality for the beneficiaries of LIFE Mission as part of the Phase III project of the LIFE Mission. The total cost of the Project as per the DPR submitted by the Municipality is Rs. 49.75 Cr. As per proceedings of Chief Executive Officer, LIFE Mission read as 1st paper above, it was decided to allot an amount of Rs. 20 Cr in 4 equal instalments as share of LIFE Mission to the Perinthalmanna Municipality for the above project according to the progress of the construction.

2. As per Government Order read as 2nd paper above administrative sanction was issued by Government to release an amount of 20 crores as Life Mission's share for the project and also to release an amount of ₹17 Crores for the project from the provision available under the appropriate Head of account of LIFE Mission in 2019-20.

3. As per Government Order read as 3rd paper above sanction was accorded by Government to constitute a Technical Committee for issuing Technical Sanction and overall supervision of the construction. Now as per letter read as 4th paper above Chief Executive Officer, Life Mission has informed that the

Secretary, Perinthalmanna Municipality has certified that the construction works are going on as per guidelines approved by the Municipality and the project would be completed within the time limit of August, 2020 and has requested to release the amount of Rs. 20 Crores assured by LIFE Mission. Hence the Chief executive Officer LIFE Mission has requested Government to accord necessary sanction for releasing an amount of Rs. 5 Cr. out of the budget provision of Rs. 175 Cr. earmarked for LIFE Mission for 2019 - 20 under the head of account 4217 - 60 - 051 - 95 plan (voted) being the 1st instalment against Rs.20 Cr. assured by LIFE Mission for the project.

4. Government have examined the matter in detail and are pleased to accord sanction for the release an amount of Rs. 5 Crore under the Head of Account 4217-60-051-95 (PV), as 1st instalment for the construction of Housing complexes at Perinthalmanna Municipality for LIFE Mission.
