ORDER

As per the letter read as 1st paper above, Government of India have released an amount of ₹258 Crores to Government of Kerala being the 1st installment of 2nd tranche of Central assistance towards Material and Administrative Contingency for implementation of MGNREGA for the financial year 2020-21. The Mission Director (MGNREGS) as per the letter read as 2nd paper above, has submitted a proposal for release of the Central share received, along with the corresponding State share. As there is no component-wise bifurcation for the central release, the Mission Director submitted the proposal based on requirement.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of ₹2,58,00,00,000/- (Rupees Two Hundred and Fifty Eight Crore only) being the 1st installment of 2nd tranche of the Central Assistance received towards Material and Administrative Components for implementation of MGNREGA along with the corresponding State share of ₹70,99,29,000/- (Rupees Seventy Crore Ninety Ninte Lakh and Twenty Nine

Thousand only) towards Material Component for the financial year 2020-21 as detailed below;
