ORDER

As per letter read first paper above, Government of India had sanctioned an amount of Rs.2,53,68,000/- to the State Government towards second installment of Central Share for implementation of the DRDA Administration Scheme for the financial year 2020-21. Accordingly, Commissioner Rural Development as per the letter read 2nd paper above has requested to release release of an amount of ₹4,22,80,000/- (Central Share ₹2,53,68,000/- and State Share ₹1,69,12,000/-) towards second installment of DRDA Administration fund for the year 2020-21. An amount of ₹1,11,24,000/- has been additionally authorised as per the Government Order read 4th paper above.

2) Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹4,22,80,000/- (Rupees Four crore twenty two lakh eighty thousand only) towards second installment of DRDA Administration fund for the year 2020-21 as detailed below :
