### ORDER

Government of India vide letter read as 1<sup>st</sup> paper above have released an amount of Rs.43898.26 Lakhs (Rupees Four Hundred Thirty Eight Crore Ninety Eight Lakh and Twenty Six Thousand Only) to the State Government of Kerala being the 1<sup>st</sup> installment of 1<sup>st</sup> tranche of Central assistance towards material and administrative contingency for implementation of MGNREGA for the financial year 2021-22. The component wise bifurcation of the amount sanctioned as per the release order is Rs.39878.91 Lakh for material component and Rs.4019.35 Lakh for administrative component. The Mission Director(MGNREGS) vide letter read as 2<sup>nd</sup> paper above, has submitted a proposal for release of Central Share received along with the corresponding state share of the material component.

2. Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of **Rs. 438,98,26,000/-** (Rupees Four Hundred Thirty Eight Crore Ninety Eight Lakh and Twenty Six

Thousand Only) being the 1<sup>st</sup> installment of 1<sup>st</sup> tranche of Central Assistance received towards material and administrative components for implementation of MGNREGA for the financial year 2020-21 along with the corresponding State share of **Rs. 132,91,64,000/-** (Rupees One Hundred Thirty Two Crore Ninety One Lakh and Sixty Four Thousand only) towards material component for the financial year 2021-22 as detailed below.
