As per the letter read as 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> paper above, Ministry of Rural Development, Government of India had sanctioned ₹15,24,31,000/- as General component, ₹12,58,63,000/- as SCP component and ₹8,71,61,000/- as TSP component to State of Kerala towards the 1<sup>st</sup> tranche of 1<sup>st</sup> installment of Central Share under NRLM/Ajeevika during the year 2021-22.

2) As per the letter read as 5<sup>th</sup> above, the Executive Director, Kudumbashree has requested to release the aforesaid Central Share along with the corresponding State Share for the above purpose.
