### ORDER

The Secretary, State Election Commission, as per letter read above had informed that three posts of Confidential Assistants were lying vacant in the State Election Commission, Kerala due to the repatriation of former Confidential Assistants to their parent departments. Hence the Commission appointed Smt. Anuja Divine Angel B L, Salem Nivas, Kunnilvila, Peyad. P.O, Thiruvananthapuram and Smt. Anupa Divine Angel B L, Salem Nivas, Kunnilvila, Peyad.P.O, Thiruvananthapuram as Confidential Assistants temporarily, on daily wage basis, in the State Election Commission, Kerala with effect from the FN of 10.08.2020 for a period of 90 days and with a daily wage of Rs.765/- (Rupees Seven Hundred and Sixty Five only), subject to a maximum of Rs.20,655/- per month, as per the guidelines in the Govt order read above. Accordingly, their period of appointment expired on 07.11.2020.

As the Commission was facing heavy work load, the Commission re-engaged Smt. Anuja Divine Angel & Smt. Anupa Divine Angel as Confidential Assistants for a further period of 90 days on the same wage rate with effect from 08.11.2020. The Secretary, State Election Commission, requested to ratify the action of the State Election Commission, Kerala in having appointed Smt. Anuja Divine Angel and Smt. Anupa Divine Angel as Confidential Assistants to State Election Commission, Kerala on daily wage basis for a further period of 90 days with effect from 08.11.2020.
